Because there are over 250,000 LGBTI people in Scotland, and based on our recent research, almost 95% have experienced discrimination because of their sexual orientation, gender identity or sex characteristics.

### Award-winning campaigns

We are experts in sexual orientation and gender identity. Within the Equality Network, the Scottish Trans Alliance project, which we established in 2007, is Scotland's centre of expertise on trans equality. Together with intersex activists, we are developing Scotland's new intersex equality work.

- Provide policy development assistance
- Undertake and publish research
- Provide LGBTI community development and engagement
